GDPR parental consent statement

- The Trust/school will not use a photograph or video of your child without consent.
- If a photograph of an individual pupil is used, the Trust/school will not use the full name of the child in any accompanying text or caption, nor will the Trust/school include any other personal information
- The Trust/school may use group or class photographs and footage with very general labels, such as *a science lesson*
- The Trust/school will only use photographs and videos of pupils who are suitably dressed and usually in school uniform
- Parents should note that Trust/school websites can be viewed throughout the world and not just in the United Kingdom, where UK law applies.
